### Guideline Adoption for Community-Acquired Pneumonia in the ...

One caregiver/support person per pediatric patient is allowed in the pediatric units and the Neonatal Intensive Care Unit (NICU). These visitors can only be parents, guardians, or family care partners. One support person and/or a trained doula are allowed to be with obstetric patients during antepartum, labor, delivery, and postpartum care.

The inpatient treatment of CAP and hospital-acquired pneumonia in children will be reviewed here.
